After consideration of the works received for the Conceptual Architectural Solution of the FC Bokelj Stadium, which were forwarded by the expert reporters of this competition to the members of the jury on February 17, 2023, out of a total of 63 works that were marked with participant codes and filed under the regular numbers from 1 to 63, the jury unanimously decided to enter 7 works into the shortlist for selection.

The selection was made after the presentation and explanation of the proposals of all the members of the jury, who agreed to select the works that adequately responded to the requirements of the location and satisfied the relevant criteria.

It should be noted that the jury made Decision no. 01-018/22-17694-2 dated March 1, 2023, officially published on the website of the Municipality of Kotor, on the extension of the deadline for making a decision on the selection of the best work until March 31, 2023 at the latest.

Also, at this meeting, after determining the shortlisted works, all members of the jury decided that after an individual review of the selected competition works, a joint discussion will be held on March 18, 2023.
