TYPE AND FORM OF COMPETITION:

Competition for the conceptual architectural design of the base station for the "Hajla and Štedim" ski center is international, general, single-stage and anonymous.

THE LANGUAGE IN WHICH THE COMPETITION IS ANNOUNCED AND CONDUCTED:

The announcer announces and conducts the competition in Montenegrin and English.

COMPETITION BRIEF:

The subject of the competition is the development of a conceptual architectural design for the base station of the "Hajla and Štedim" ski center, located within the scope of the Local Site Study of Hajla and Štedim ("Official Gazette of Montenegro - municipal regulations", No. 22/18), Municipality of Rožaje.

COMPETITION OBJECTIVE:

The Competition objective is to obtain a functional and recognizable conceptual architectural design that will, above all, meet the prescribed requirements and achieve maximum alignment of all aspects specified in the Competition Brief, with crucial importance placed on establishing a direct and most efficient connection between the base station and the departure station for the ski lift.

COMPETITION DEADLINE:

The deadline for submission of entries was Thursday, August 15, 2024, by 13:00h (Montenegrin local time).

WORK OF THE JURY

The receiving and opening of the competition entries was carried out by the rapporteurs, along with the president of the Jury, dr Svetlana Perović, on August 19th, 2024. The Report on Receiving Competition Entries has been prepared, which is an integral part of this Report. It was noted in the same document that by the specified deadline, i.e., by 13:00 (local time in Montenegro) on Thursday, August 15th, 2024, a total of 37 competition entries had been submitted, while 3 competition entries were submitted after the deadline. The rapporteurs downloaded folders labeled "author's data" for safekeeping, which the jury does not have access to until the determination of the final ranking list of participants and signing the decision on the distribution of prizes.

The jury process began on the day the competition documentation was delivered to the jury members, on August 19th, 2024. In addition, three jury sessions were held on September 11th, 12th, and 13th, 2024.

A/ First session of the Jury

The first jury session was held on September 11th, 2024. At the beginning of the first session, after a detailed individual analysis of all competition entries submitted within the specified deadline, the jury noted that none of the competition entries fully addressed all the challenges of the location and the requirements set out in the Competition Brief. Considering the complexity of the task and the effort put in by the authors, the jury unanimously decided to jointly review all the works submitted before the deadline once again.

Following this, the jury noted that the competition entry with serial number 28 was submitted under the code "ski.hajla@gmail.com". Given that the email address was created in accordance with the Competition Announcement and the anonymity of the author was not compromised, the jury allowed the entry under the code "ski.hajla@gmail.com" to continue participating under the code "HAJLA", deeming that the author unnecessarily displayed the entire email address on the graphic and textual sheets.

Following that, a review and evaluation of the 37 competition entries submitted within the specified deadline was carried out, specifically the entries with the following codes:

After that, the jury evaluated the 20 entries that were selected for the second round and concluded that the following entries, based on their design, spatial, and functional characteristics, meet the jury's criteria to proceed to the third round:

These competition entries demonstrated a distinctive individual approach to design in terms of the spatial concept of the buildings, their relationship to the surroundings, and the organization of spatial contents.

B/ Second session of the Jury

The second jury session was held on September 12th, 2024. The jury reviewed the content of the competition documentation for the entries with the following codes:

From the abovementioned competition entries, a final selection was made for entries that possess qualities and potential for prize consideration. **The five selected entries are: RCL2024, 12321, HAJLA, 213742, and 87106.** The jury unanimously decided that these entries stand out due to their architectural expression compared to the others and have demonstrated quality and potential in addressing the specific requirements of the location.

C/ Third session of the Jury

At the third session, held on September 13th, the jury reviewed and evaluated the five competition entries that were selected as finalists in the previous session. These entries are coded: **RCL2024, 12321, HAJLA, 213742, and 87106.**

Upon reviewing the competition documentation of the five works that reached the final round, the Jury concluded that, although the proposals demonstrated a satisfactory level of quality in key architectural aspects such as spatial organization, aesthetic harmony, and functionality, none of the solutions fully addressed the complex challenges posed by this location. Considering the comprehensive and complex nature of the task, the jury unanimously decided that it is not justified to select a first-place entry at this stage. Therefore, it was decided that the competition will continue as an extended competition in accordance with Article 5 of the Rulebook on the procedure of announcing and conducting public competitions for conceptual architectural solutions (Official Gazette of Montenegro No. 19/18, 2/24, and 8/24).

The jury formulated the clear tasks and obligations for the participants in the extended competition, which will be provided to the participants on the day of publication of this Report.

The deadline for submitting revised competition entries is October 11th, 2024, by 13:00 (local time in Montenegro). After this, the jury will evaluate the revised entries, establish the final ranking of participants, and decide on the distribution of prizes.


