PRIZE FUND

Total prize fund for award of prizes amounts to net €22.500,00.

The Jury will award the first, the second, the third prize and one honourable mention, in the following amounts:

I prize - 13.500,00 €
II prize - 5.500,00 €
III prize - 2.500,00 €
One honourable mention - 1.000,00 €

The compensation for adjustment of the best-ranked entry, in line with the recommendations of the Jury, amounts to €1,000.00 and it is included in the amount of the prize. The amounts of prizes and honourable mention are shown in net values.

The jury reserves the right not to award any of the listed prizes if the submitted entries do not meet satisfactory criteria, as well as to establish special awards and recognitions.

The Jury, by a majority vote, has decided not to award prizes or honourable mentions for the entries in the extended competition, as the designs were not improved in accordance with the jury's feedback and expectations, and entries exhibited irregularities in urban parameters. In this regard, the jury has decided, by majority vote, to grant special equal non-monetary recognitions – commendations – to the submissions under the codes: RCL2024, 87106, 12321, and 213742, which demonstrated notable qualities in certain aspects.

With this decision made, the jury proceeded to prepare its Final Report on the work conducted.
