## 1. UVOD / INTRODUCTION

Raspis konkursa za idejno rješenje revitalizacije i uređenja park šume Zlatica u Podgorici, objavljen 8. septembra 2025. godine, definisao je vrstu i visinu nagrada, otkupa, obeštećenja i nadoknada.

The Competition for conceptual design of a Competition for the conceptual design of the revitalization and development of the Zlatica park-forest in Podgorica, which was published on September 8<sup>th</sup> 2025, defined prizes, honorable mentions, indemnities and compensations.

Ukupan nagradni fond za dodjelu iznosi 49.000,00 eura, a dijeli se na sljedeći način:

Gross prize fund amounts to 49.000,00 €, and it shall be divided in following amounts:

I nagrada / First prize	25.000,00 €
II nagrada / Second prize	12.000,00 €
III nagrada / Third prize	6.000,00 €
Tri otkupa po / Tree honorable mention each	2.000,00 €

Nagrade, otkupi, kao i naknade članovima žirija i izvjestiocima, navedeni su u bruto iznosu.

Prizes, redemptions, as well as compensations to the jury member and reporters, are specified in gross amount.

Žiri zadržava pravo da ne dodijeli neku od navedenih nagrada ukoliko konkursni radovi ne budu na zadovoljavajućem nivou, kao i da ustanovi posebne nagrade i priznanja.

The jury reserves the right not to award any of the listed prizes if the submitted designs are not at the satisfactory level, as well as to establish special awards and notable mentions.

## 2. ODLUKA ŽIRIJA / JURY'S DECISION

Na konkursu je pristiglo 19 radova. Žiri je izvršio pregled 18 idejnih rješenja, a nije razmatrao rad pod šifrom **11060**, iz razloga navedenih u Zapisniku sa otvaranja konkursnih radova.

A total of 19 works were submitted to the competition. The jury reviewed 18 conceptual designs and did not consider the work under the code 11060, for the reasons stated in the Minutes from the opening of the competition entries.

Na prvoj sjednici žiri je izvršio pregled svih radova i ustanovio koji radovi su stekli uslov za dalje razmatranje. Takođe, žiri je na prvoj sjednici izabrao predsjednika.

At the first session, the jury reviewed all the works and determined which ones met the criteria for further consideration. The jury also elected a president at the first session.

Na drugoj sjednici žiri je pozitivnom metodom selekcije radova odabra 9 radova koji su prošli u drugi krug: 251010gz, 101708, 68173, 23102, 45012, FNS11BAR25, 21578, 15545 i JCVN6

At the second session, the jury used a positive method of selecting works and chose 9 works that advanced to the second round: 251010gz, 101708, 68173, 23102, 45012, FNS11BAR25, 21578, 15545 and JCVN6

Nakon diskusija na trećoj sjednici žiri je odabrao šest radova koji su ušli u uži izbor za dodjelu nagrada i otkupa. Žiri je jednoglasno dodijelio **prvu nagradu** radu pod šifrom **101708**, **drugu nagradu** dodijeljena je radu pod šifrom **45012**, a **treću nagradu** radu pod šifrom **FNS11BAR25**. Žiri je jednoglasno odlučio da se **tri otkupa** dodijele radovima pod šiframa **15545**, **21578** i **JCVN6**.

After the discussions at the third session, the jury selected six works that made the shortlist for awards and purchases. The jury unanimously awarded the first prize to the work under the code **101708**, the second prize to the work under the code **45012**, and the third prize to the work under the code **FNS11BAR25**. The jury also unanimously decided to award three purchases to the works under the codes **15545**, **21578** and **JCVN6**.




